- In respect of one of the Subsidiary Company, the accumulated losses incurred of Rs. 534.42 Lakhs on June 30, 2021 (31.03.2021: Rs. 534.01 Lakhs) have resulted in the negative net worth of Rs. 492.49 lakhs (31.03.2021: Rs. 492.08 Lakhs). The Subsidiary's current liabilities, as on 30.06.2021, exceed its current assets by Rs. 527.29 Lakhs (31.03.2021: Rs. 526.94 Lakhs) and turnover during the quarter ended June 30, 2021 is Rs. NIL (FY 2020-21: Rs. NIL). Due to the lack of working capital required the operations of the Subsidiary Company have been substantially curtailed and its ability to continue as a going concern is solely dependent upon the infusion of funds for its operations.

We conducted our review of the Statement in accordance with the Standard on Review Engagements (SRE) 2410 'Review of Interim Financial Information Performed by the Independent Auditor of the Entity', issued by the Institute of Chartered Accountants of India. This Standard requires that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatement. 5. Material uncertainty related to going concern in respect of a Subsidiary

We draw attention to note 4 in the consolidated quarter ended financial results, which indicates that one subsidiary company incurred a net loss of Rs.0.41 Lakhs during the quarter ended 30 June 2021 and, as of that date, the company's current liabilities exceeded its total assets by Rs.492.49 Lakhs. As stated in the said Note, these events or conditions, along with other matters as set forth in Note, indicate that a material uncertainty exist that may cast significant doubt on the subsidiary company's ability to continue as a going concern. Our conclusion on the statement is not modified in respect of this matter.

6. We did not review the interim financial results and other financial information of four (4) subsidiaries and one (1) unincorporated entity included in the consolidated unaudited financial results, whose interim financial results and other financial information reflect total revenues of Rs.10368.36 Lakhs, total net profit after tax of Rs.348.47 Lakhs and total comprehensive income of Rs.348.47 Lakhs, for the quarter ended 30 June 2021, as considered in the Statement. These interim financial results and other financial information have been reviewed by other auditors, whose reports have been furnished to us by the Management and our conclusion on the Statement, in so far as it relates to the amounts and disclosures included in respect of these subsidiaries, is based solely on the reports of the other auditors and the procedures performed by us as stated in paragraph 3 above.

Our conclusion on the Statement is not modified in respect of the above matter.

7. Based on our review conducted and procedures performed as stated in paragraph 3 above and based on the consideration of the review reports of other auditors referred to in paragraph 6 above, nothing has come to our attention that causes us to believe that the accompanying Statement, prepared in accordance with the recognition and measurement principles laid down in the aforesaid Indian Accounting Standards specified under Section 133 of the Companies Act, 2013 as amended, read with relevant rules made thereunder and other accounting principles generally accepted in India, has not disclosed the information required to be disclosed in terms of Regulation, including the manner in which it is to be disclosed, or that it contains any material misstatement.
